

Annual General Meeting of the Suffolk Agricultural Association (SAA) Meeting held on Tuesday 11th February 2020 at 11.30 am at Trinity Park

Present: 79 Members attended.

The SAA Chairman (David Nunn) welcomed all to the Association's 189th Annual General Meeting. In normal circumstances the Associations President (Stephen Miles), would chair the meeting but sadly was unwell; all wished him a speedy recovery. The meeting, being properly convened with a quorum, commenced at 1130 a.m.

Before the start of formal business all remembered Vice Presidents and Members of the Association who had died since the 2019 AGM. The Chaplain, the Reverend Brynn Bayman, led the tribute and minutes silence for the following: William Bryce, Roger Clark, James Downie, Graham Henderson, Anthea Langton and John Leaman.

1. Apologies for Absence.

44 apologies were received.

2. Adoption of the Minutes of the 2019 AGM.

The President noted that minutes of the 2019 AGM had been approved by the Trustee Board. In turn all present approved the Minutes. The President declared the motion to adopt the minutes.

3. Ordinary Resolution 1 - To Receive and Adopt the Trustees' Report and Audited Financial Statements for the year ended 30 September 2019.

Trustees' Report for the year:

The SAA Chairman reported it had been an exciting year including a wonderful Suffolk Show. TPEL had had a very good year, the ever-popular Christmas Parties along with many other activities including support to the Ed Sheeran Concerts had made for a busy and positive period.

The Show and TPEL both provided positive financial returns and with Simon Tucker, our Treasurer continue to work hard to find more economic ways to run the business.

Governance and internal controls have also been subject to review and thanks expressed to Karen Sharpe who has carried on the work commenced by Loudon Greenlees (previous Treasurer).

The Board continues to look at reinvestment into the site, particularly toilet blocks; this may include demolition of some and the rebuilding of others.

Time has been spent looking at the future purpose of Council. The conclusion being that Council continues to give valuable guidance to the Trustee Board on key matters and as a method of communication to the county and beyond.

Into the future there should be no limit to member numbers and a focus on finding next generation members.

An Alumni will be set up for those members stepping away as important to maintain the connections.

The Chairman thanked the Board Members for all their hard work and time, freely given, during the last year. Also, to thank Phillip Ainsworth and all his team for their enthusiasm and commitment, without which we would not be able to deliver our many activities.

Audited Financial Statements for the year ended 30 September 2019 – Simon Tucker (Treasurer):

The Treasurer opened by noting that financial statements for the year ended 30 September 2019 received a clean audit opinion from the auditors Price Bailey and were approved by the Association's audit committee and by the full Trustee Board in December.

The Treasurer proposed adoption of the accounts which was seconded by James Black.

The Chairman then declared the motion carried as voted by those present and by the unanimous proxy votes.

4. Ordinary Resolution 2 - To elect Mr William (Bill) Kemball, currently President-Elect of the Suffolk Agricultural Association, President of the Association 2020 Suffolk Show.

The Chairman asked the Vice-Chairman, Peter Over to propose that William (Bill) Kemball be elected as President.

The proposal was seconded by John Wall.

The Chief Executive declared the motion carried as unanimously voted by those present and by proxy votes.

William Kemball thanked all those present for voting for him saying how very proud he was. He first stewarded in 1959 and had had a lot of fun making many friends along the way. Delighted that Peter had mentioned his late father and proud to be following in his footsteps. Also proud of his family, particularly Bee, for what they have achieved and contributed to the Association.

5. Ordinary Resolution 3 - To elect Mr David Barker MBE as President Elect of the Suffolk Agricultural Society for the 2020 Suffolk Show.

William Kemball proposed David Barker MBE as President Elect for 2020. He continued that it he was very pleased to invite David to take on this role mentioning that David had steward since 1980 but unlike most others, who had started in car parks, David came straight in as the tractor handling

steward and had many roles since, Tradestands, Press and one of the founders of the Schools Farm and Country Fair. He was Show Director in 1994 and continues to steward, with his farm also winning many awards over the years. David's passion about conservation was also mentioned.

The proposal was seconded by David Nunn.

The Chairman declared the motion carried as unanimously voted by those present and the proxy votes in favour.

The Chief Executive confirmed that the proxy votes received for this resolution were all in favour with 2 against.

6. Ordinary Resolution 4 - To re-elect the following retiring members of Council who have been nominated for re-election; in accordance with Article 11.1.

The candidates for re-election:

Angie Ashby-Hoare, James Black, Countess of Cranbrook, Andrew Fairs, Bob Feltwell, Oliver Holloway, Jane Rabagliati, Lord Tollemache and Philip Westrope.

Rupert Eley, Toby Pound and James Tuckwell decided not to offer themselves for re-election. Note that between the time proxy forms were sent out and today James Tuckwell informed us that he did not wish to be considered for re-election.

Although the proxy forms required this Ordinary Resolution to be voted on in many parts, there was such a strong majority of proxy votes in favour of the election of each individual it was proposed that, as in previous years, the meeting should vote on all the candidates as one resolution.

The Chairman declared the motion carried as voted by those present and by proxy votes in favour. The Chief Executive confirmed the proxy votes received for this resolution as a majority in favour with 3 against and 14 abstentions.

7. Ordinary Resolution - To re-appoint Price Bailey LLP as auditors of the Association for the 2019 financial year to take office with immediate effect, to hold office until the conclusion of the next Annual General Meeting and to authorise the Trustee Board to fix their remuneration.

The Treasurer proposed the re-appointment of Price Bailey LLP as auditors and Loudon Greenlees seconded the proposal.

The Chairman declared the motion carried as voted by those present and by proxy votes were in favour. The Chief Executive confirmed that of the proxy votes received were all in favour.

8. To receive a report on the arrangements for the 2019 Suffolk Show.

The Honorary Show Director, Bee Kemball, reported as follows:

9. To propose a vote of thanks to the 2019 Honorary Show Director and Honorary Deputy Show Director.

The Chairman proposed a vote of thanks to the Show Director, Bee Kemball and Bruce Kerr, Deputy Show Director for 2019.

Peter Over presented Bruce Kerr with a thanked him for all his hard work.

Peter Over then presented Bee Kemball with a Decanter thanking her for three very successful years as Show Director.

10. To receive a report on arrangements for the 2020 Suffolk Show.

Bruce Kerr, Show Director reported on the 2020 show preparations:

11. AOB.

The Chairman introduced Julian Taylor from the Royal Norfolk Agricultural Association (RNAA) to report on the Royal Agricultural Society of the Commonwealth 2020, the twenty ninth conference running form 30 June to 11 July, hosted by the RNAA. Business leaders will discuss global challenges and new opportunities. Next generation delegates will share their experiences and new ideas. Twenty-three countries will be represented.

Topics include: Circling the World, Circular Economy and Agriculture and the Three Pillars – Environment, Agritech and Engagement.

Four volunteers from Suffolk needed to act as guides. Places in Suffolk to be visited include - Dingle Dell Pigs, Suffolk Food Hall, Chadwell Acre, New Market racing and Waveney Valley. Discounts for RASC members and Next Generation Bursaries available.
